#### 2. OLD BUSINESS

A. APPROVAL OF THE MINUTES OF THE DISTRICT'S QUARTERLY BOARD OF DIRECTORS MEETING HELD THURSDAY, OCTOBER 20, 2022

## A. SECURITY UPDATE

Jim Whyte reported that, from November 14, 2022, to December 14, 2022, two part-time outreach members had 48 public engagements (8 repeated individuals), 45 men and 4 women, within the East Loop and adjacent areas.

Jim Whyte noted the 2022 year-end report included a slight increase in crime, mostly driven by property crimes (in particular, vehicle thefts are up significantly), while other areas had double digit increases in property crimes. He reported that video cameras are paying dividends. He also added that they are looking at new tech for officers to track engagement with businesses. A possible cost share item for business owners and the District would be additional film on business doors and windows to prevent smashing break-ins, estimated cost is between \$35 and \$105 per square foot for the film which would be rock proof/hammer proof and bullet proof.
